Extract of General Conditions and Notification of Information Relating to Protection Cover

CIVIL RESPONSIBILITY WORLDWIDE - Plan 1

The Insurer, within the limit of the sums detailed below, insures the member against the financial consequences of Civil Responsibility (CR) which they may incur as a result of a hunting action worldwide (except France and overseas departments and territories). Physical injury (unlimited), material and non-material damages (up to €6,000,000, excess €75), Criminal Defence and Appeal proceedings (up to €20,000).

INDIVIDUAL ACCIDENT - Plan 2

In the event of an accident, we cover participants in *Chasse Safari* trips 24/7 (death, Permanent and partial Disability), from the moment they leave home until they return, for a maximum period of 30 days, throughout the world.

ASSISTANCE WITH MEDICAL COSTS - REPATRIATION - DEPOSIT- Plan 3:

- Sick or injured during stay, we organise and arrange repatriation
- Sick or injured during stay, we cover reimbursement in addition to medical costs, prescribed medications and hospitalisation costs (Excess of €100 Limited to €10,000) urgent dental treatment (cap of €77).
- Arrangements for early return home following interruption to stay (death of a spouse, an ancestor or successor, first cousin, immediate aunt or uncle, resident of the same country). Basic rate 1st class return ticket by train, or economy class, if by plane.
- Arrangements for the repatriation of a body in the event of death; cost of coffin, and of placing body in coffin (capped at €460).
- Arrangements for the sending of medication lost at the place of stay
- Arranging to send a message, if not possible
- Cash advance following loss/theft of means of payment, or medical expenses (capped at €1000).
- Financial aid following legal proceedings or involuntary imprisonment; fees advance and help in appointing legal defence (up to €1000); advance payment to cover bail demanded for temporary release, (capped at €8000).

CROSS-BORDER SECURITY ASSISTANCE IN THE EVENT OF GEOPOLITICAL DISTURBANCE - Plan 4:

Rescue mission if officially recommended by Government; arranging payment or reimbursement of costs in the event of repatriation (up to €7,650); covering the costs resulting from immobility in the event of non-repatriation (€305/day, for a maximum period of 8 days).

FULLY COMPREHENSIVE INSURANCE FOR HUNTING FIREARMS AND ACCESSORIES - Plan 5

Hunting firearms (authorised under current regulations), as well as accessories like glasses, binoculars or cases are insured against all risk of loss, theft, and other material damage. Extension of cover up to €150 for your baggage and €380 for items of clothing (Capped at €20,000 in the event of theft from a vehicle).

INSURANCE DURING TRANSPORT: "COMPREHENSIVE COVER FOR MATERIALS: SHOTGUN, CAMERA, VIDEO, FISHING ROD" - Plan 6

Protection cover against the risks of transporting shotguns, cameras, fishing rods and accessories (excluding ammunition) taken on safari or on a fishing party, acquired anywhere in the World, on board any form of transport (by sea, air and/or land) or in any place of stay for a maximum of 30 days after becoming a member.

CANCELLATION OF JOURNEY WORLDWIDE and THEFT/LOSS OR DELAY OF BAGGAGE - Plans 7, 8 and 9

The Insurer will insure the Insured Person for sums withheld by the organiser of the trip and invoiced in accordance with the General Conditions of sale of the trip (with the exception of application expenses) if the Insured Person is forced to cancel taking part in the trip, as a result of any of the following types of events: death, accident or serious disease, relapse, destruction, deterioration, theft at private or business premises, redundancy, visa refusal, theft of passport, pregnancy, court appearance, ...(all details available on request). Effective from the moment the Insured person is registered as a participant on the trip, with said registration stating the insurance cover taken (Option 1 or 2).

Option 3 supplementary element: We pay for the consequences of the theft/loss or destruction of your baggage, and personal effects (maximum €1,800/piece of baggage) in the following circumstances : theft or loss en-route if entrusted to the care of a transport company; theft during your stay following a burglary at the place or vehicle where they were located, or an attack on the person transporting the baggage; total or partial destruction resulting from fire, explosion, water damage or from a natural phenomenon. In the event of travel by air, if baggage is not sent to the destination airport (on the outbound journey), or if it arrives more than 24 hours late, essential purchases will be reimbursed on presentation of receipts for up to 200 Euros (This payment is non-cumulative with other payments under protection cover for "Baggage.") Items of value are included in the insurance limit for an amount of up to 50% of protection cover capital, and those acquired throughout the journey or stay are included in the insurance up to a maximum of 25% of the insured capital sum (€50 excess for each loss). This protection cover begins from the time embarkation formalities take place and ends with the last service provided by the trip organiser. Please note that this risk cover cannot be taken out on its own. It must be taken out with journey cancellation: option 1 or 2.

Any member may obtain on request, and if they so wish, a copy free of charge of the full text of the contract, general conditions, and where relevant, annexes and amendments. In accordance with the terms of articles L.112-2-1i and L. 112-9 of the Insurance Code: "Any physical person who is subject to cold-calling at their place of residence or work, even at their request, and who signs an insurance proposal or a contract for purposes unrelated to their business or professional activity in such circumstances, is able to withdraw from this proposal or contract, by means of a registered letter sent with a request for an acknowledgement of receipt, within a period of fourteen days from the date the contract is concluded, without having to provide any justification for doing so, or facing any penalty". A model of the withdrawal letter is included in the general provisions. Any withholding of information or providing of inaccurate information in the statements is likely to lead to measures specified in Articles L113-8 (declaration of null and void) and L113-9 (reduction of payments) of the Insurance code. This information is required by our company to deal with your request. In accordance with the Freedom and Information Law of January 6, 1978, you can exercise your right to access, correct, and oppose information which concerns you, and held on any file used by our company, our insurers and reinsurers with regard to the Proassur Group - 27 rue des Bourguignons à Bois Colombes (92270).
